Clean and Serene Makes a Motion:

- a. Whereas the previous practice by the literature committee has been to sell literature, turn the sale proceeds (funds) over to the Treasurer, and to order literature as required using the Anchorage Area account with NA World Services. And then to let the AASC treasurer pay the NAWs literature invoice or bill.
- b. This motion would authorize the literature committee to buy replacement literature as needed directly (from NAWS) with the proceeds (cash) of sales. The treasurer would not pay the invoice.
- c. Further this motion obligates the literature chair to provide a written monthly report of income and expenses and stock on hand. A form for this purpose has been attached. This provision is consistent with the AASC guidelines that the literature subcommittee provide a "written financial report to include all income and expenses prior to disbursement of AASC funds".
- d. Further this motion obligates the AASC treasurer to reimburse the literature committee for H&I and PI expenditures, which would not exceed their respective budgets.

<u>Intent of the motion</u> is clarify how Literature does business. This method maintains literature services in the event that the AASC finances drop below the prudent reserve, so avoiding interruption in services; maintains accountability to the AASC; and continues to provide service within budget to H&I and PI subcommittees.

There should be no financial impact from this motion. Literature committee had to handle cash before and will still have to handle it.

- 2. Reviewed the Area expenses/revenue 12-month report. Purpose was to just get a handle on reading it. (Thanks to Frank for making copies of the 2015 report.
- 3. Reviewed the "Essential Expenses Summary" form the Agenda. These are expenses that are not cut even when we have a freeze on expenditures because we are below prudent reserve.
  - Average group revenue was \$250 per month, and \$3000 per year in 2015.
- 4. Reviewed the group donations. Group donations averaged \$390 per month and \$4670 per year.
- 5. The revenue versus expenditure can be summarized as follows

So it may be concluded that the groups can afford essential expenses.

- 6. Also touched on Activities revenue from 2015 approximately \$800 was raised.

  - c. Sell literature and buy literature with proceeds of sales. Report sales and purchase to Area.

Current literature chair has just requested to do "c", switching from the method "a".

Note that Meeting on the corner donated an average \$20 per month but took 6 months off. Also UAA has only been open since June. See the donation pattern in the 2015 spread sheet.

Most groups did double up donations in July and September after the bi-monthly GSF trials. Area executive committee advised against another GSF-in-lieu-of Area in August because of a perceived drop in revenue. Really it was cash flow issue – not enough cash reserves- that created a problem with literature and doing business in August and September.

*On the face of it,* expenses exceed the revenue by \$1131 per year. H&I used their monthly stipend 11 or 12 months out of 12months – let us assume \$1200 for the year. Neither is the PI subsidy reported. PI may have used \$100 or \$200 for informational pamphlets to stock racks. For general purposes we may assume that we spent \$1300 spent on PI and HI literature.

So really that leaves \$170 in unsold literature stock.

We as an Area fellowship (or groups) do not have any way to quantify (or assess the value of) the increased stock on hand. Literature needs to provide inventory periodically.

What is the vision for literature going forward?

- How much stock should literature keep on hand?
- When should Literature inventory its stock? Annually? Monthly?
- We need to track literature sales for a while if we are going to maintain stock- how will we do this?

## Literature and Accountability

The Sisters raised the question in the Area Sharing session regarding accounting for the inventory.

## **Activities**

Note the Activities contribution in April 2015 of \$1067. This included returning seed and profit from the Anniversary in Spring 2015. From the April (or May) Activities report, the gig profit was \$800. That revenue put Area above the prudent reserve, allowing Area to do business.

There was no Activities committee until October or November 2015. Area seeded Activities with \$750 in October or November 2015, which is not reflected in the report.

## **Budget**

So what is our budget, if we had one?

- Lets Assume that literature pays for itself. If we buy \$500 worth each time, we receive 15% off, which makes literature a wash.
- On this iteration, lets assume that activities breaks even; we will see how much activities must raise in funds as this proceeds.

Note that the group donations for 2015 were approximately \$4650. This leaves a revenue shortfall of about \$800.

## **Reporting Format**

The rolling 12-month reporting format of revenue and expenditures paints a picture, except it neglects balance. Also it is not obvious about the PI and H&I budgets.
