Literature Motion

Clean and Serene makes a motion that the Literature subcommittee adopt the following practices:

- That Literature subcommittee bring its literature stock to the Area meeting for sales.
 Literature subcommittee can continue to deliver literature but this simplifies
 distribution since the literature subcommittee and the groups attend the Area
 subcommittee. (in case the GSF motion passes, then Literature subcommittee would
 attend the GSF too.)
- 2. Literature will not make orders from NAWs that are under \$500. For all but special orders, we get 15% off from NAWS when we buy in bulk over \$500. (15% generally pays for the freight cost. 15% of \$500 is \$75.)

Intent of the Motion:

- i. The intent is to better serve the groups and the Literature subcommittee by making sales more convenient.
 - Generally groups have a meeting soon before Area so the groups can figure out their literature order while they are deciding their 7th Tradition.
 - This is a convenient arrangement because both the Literature subcommittee and the groups attend the Area meeting
 - This is pretty common practice in other places.
 - In the case where the Literature subcommittee hands over literature sales receipts to the treasury, this is convenient because the groups, literature, and treasurer are all at the meeting.
- ii. The intent of the 2nd part is based on prudent use of funds.
 - The 11th concept says that "NA funds are to be used to further our primary purpose, and must be managed responsibly". Paying an extra 15 % is not responsible.
 - From March 2015 to Feb 2016, our Area bought \$5460 worth of literature, which is approximately \$455 per month. In other words, Area can buy \$500 worth of literature almost once per month.

Group Support Forum – Notes

May 21, 2016

Our Gratitude Speaks

We opened with the Serenity Prayer, and read the Concepts and Vision for NA Service.

1. What about getting motions passed? There was a discussion about approving "urgent" motions. For instance we do not have an Activities Chair and we need to waive service requirements for the nominees (and vote on a nominee.)

Point was made that most motions are not very urgent but things come up that are urgent that require a vote of the groups.

Lou Ann suggested that the Chair could call a special meeting. Going further, the Chair could take a straw poll at the Area meeting if members would support a special meeting prior to vote on such and such a motion, which gets around the Chair just deciding what is urgent or not. Brief "special meetings" could be before the GSF.

2. There were concerns regarding changing the nature of the GSF and Area.

Susan shared that the GSF is currently small and anyone can contribute and be listened to. "Area" is a bigger platform and it will be more difficult for members to speak up; Area can be more intimidating and GSF will lose some its intimacy.

Doug responded that yes some of the intimacy of a "small" meeting would be lost, but that more voices would bring more ideas, and make for a better understanding or conscience. Members are more likely to show up to a Monday meeting because they are used to it.

Michelle shared that there is something about the Area meeting every month that fosters something, such as unity and respect, or just consistency, that may be lost if Area does not meet monthly.

Response was that we would not lose that intangible by alternating GSF and Area monthly. The Groups should send a GSR (or at least a group member) to represent at the GSF, which would maintain the sense of community and continuity.

3. Doug summarized a conversation he had with Keith because Keith raised good points. Keith felt that the 2015 experiment with the GSF alternating with Area (June and July 2015) was a "failure" primarily because we had problems collecting the 7th Tradition. Doug disagreed saying that groups that generally donate 7th tradition *do* save their 7th and donate it when Area reconvenes. And revenues are down in July and August anyway because attendance drops off a bit in summer. The root of the money problem in 2015 was that "our" bank account was so low because Activities was inactive. And if Area had to, it could collect 7th at the GSF.

Trying to get at Keith's general opposition to the motion, Keith feels that we have been making progress at Area lately because Area is meeting monthly. Literature had been such a problem for a while and we spent a lot of Area meeting time on it, but we resolved it and now we are moving on. Why change it.

4. Communication: Doug introduced the idea of Google groups.

Doug reported that he has a courtesy membership to the Dallas Area Google groups. Doug has been getting subcommittee chair reports, treasury reports, GSR group reports, notices of events (including GSF, Area meeting, service planning meetings, speaker jams, etc.), and requests for help in a few cases such as at an activities dance. Doug does not understand the administration end of it but he has been looking at Google groups on You Tube.

In his discussion with Keith, Doug brought up the idea of a Google groups to bolster communication. Keith liked that and said he could get on board with alternating Area and GSF if we implemented the Google groups.

5. Who should go to the GSF?

Mike and Lou Ann were pretty sure that the GSRs (or at least someone from a group if not the GSR) should attend the GSF. Lou Ann said that way the GSRs know what is going on. No one voiced any opposition to this.

We did not talk about the need for others to go to the GSF.

6. Other comments

- "There will be some confusion about what is meeting each month"; is it the GSF or the Area? Doug responded that we could develop a 12-month calendar alternating green and yellow for the months when the GSF and Area met. Also, Dallas Area has a calendar with three meetings the meet quarterly and they do it that way.
- We could use "Blackboard" instead of Google Groups. There are probably other tools out there.

- 7. Why bother with the GSF.
 - Doug replied to this. The best reason for the GSF is that it is a discussion based forum. Discussion is limited to the Sharing session at Area, or in the course of a motion. Both are very limited because the fellowship won't tolerate a long area meeting.
- 8. Mike suggested that at each GSF, the facilitator pose "Is there any issues that any group has?"

Follow Up:

The following were agenda items that we did not address.

- 1. Discuss the Local Service Board (executive committee and Subcommittee chairs) meeting separately from the GSF when the Area does not meet. This is so in the NAWS "SSP model". Provisionally, this is included in the draft motion to alternate GSF and Area (attached).
- 2. What Area officers should go to the GSF? Chair, V. Chair, Secretary?
- 3. How do we select a Facilitator?
- 4. How do we separate the "Service Improvement" (herein called "planning") meetings from the "Group Support" topics? Area improvement is fertile ground for growth, but we neglect group support at our peril. "Building Strong Home groups" is important to anyone who belongs to a group, particularly any that are struggling, and there are a number of those.
 - Doug the more I think about this, I believe we should go to a quarterly system of meetings: Area, Planning, and GSF. That way GSF is for groups support only.
