- **Alternate Treasurer** — Terry B nominated by *Morning After*. Terry is the incumbent Treasurer and meets all the service and clean time requirements.

Anchorage Area Service Committee met in regular session on September 10.

**Treasurer Report**

There was an increase in the AASC bank balance from August to September by \$255.91. The current bank balance is \$2120.08, which is \$620.08 over our prudent reserve threshold.

**Old Business**

There was the vote to nominate Regional positions:

- Tony L vote for nomination to **Regional Alternate Delegate** PASSED. This will now be taken to the Regional Meeting in October, and the Areas will take this nomination to their groups for approval. The final vote will probably take place at Region in December or January.
- Mandy H from Kenai vote for nomination to **Regional Public Information** PASSED. This will now be taken to the Regional Meeting in October, and the Areas will take this nomination to their groups for approval. The final vote will probably take place at Region in December or January.

There was the Vote for Regional Positions:

- Lou Ann vote for **Regional Literature**—PASSED. Kenai had brought this nomination to the last Regional Meeting. Anchorage Area is now prepared to vote this in October.

**New AASC Business**

Most of the new business consists of nominations and motions to amend the guidelines because these are voted on semi-annually in April and October, and next month is October.

**Activities Motion:** Clean and Serene made a motion to amend the AASC Guidelines for Activities as follows (the **Bold Italicized** print is the amendment). Road to Recovery seconded the motion.

AASC Guidelines, Article X, Section 3, (1) Activities

- (a) Organizes events and functions as requested and voted in by AASC. ***These events should include the following annual activities:***
  - i. ***NA in Alaska Anniversary Celebration (January or February)***
  - ii. ***Memorial Day Picnic (on or about Memorial Day)***
  - iii. ***Solstice Campout (on or about Solstice)***
  - iv. ***Unity Day Celebration (synchronized with World Unity Day)***
  - v. ***Halloween Celebration (unless Anchorage is hosting the Regional Convention in October or November)***
  - vi. ***Thanksgiving Narathon***
  - vii. ***Xmas Narathon***

***Additionally, it is recommended that:***

- ***At least two events per year be fund raising events;***
- ***Activities coordinate with the AASC and other Subcommittees to produce Learning Days and combine it with a fun event;***
- ***And Activities assist with Regional Assembly when it is located in Anchorage (funds provided by Region).***

***Activities Subcommittee may plan other events. The Area committee seeks to be advised of additional events in advance though it is understood that because of time constraints this is not always possible.***

***Activities may also come to AASC and advise AASC that it will not produce an event because of some circumstance.***

- (b) Manages, maintains, and accounts for \$750.00 seed money to roll forward monthly and any time funds accrued exceed \$1,500; those excess funds are to be turned over to the Area Treasurer with the accountable report and any other funds collected on behalf of AASC.

## Unity

The First Tradition states that “Our Common Welfare Should Come First, Personal Recovery Depends on NA Unity”. Lately, there has been some significant differences between members of the Anchorage Area and the Convention Committee regarding the policy, “the Convention is an Adult Event”.

First “Unity is a must in NA”. And though there are

- (c) The main purpose is to facilitate entertainment activities that are consistent with the Twelve Traditions, paying special attention to Tradition One (Our common welfare should come first; personal recovery depends on NA unity.) and Tradition Five (Each group has but one primary purpose—to carry the message to the addict who still suffers.).
- (d) Provides the AASC Treasurer with a monthly written financial report to include all income and expenses prior to disbursement of AASC funds. e.
- (e) Maintains written records of activities, expenditures, mailing lists, etc.

## INTENT OF THE MOTION

The intent of this motion is to provide guidance to the Activities Subcommittee. AASC activities are a series of projects which requires a lot of planning, coordination and human and financial resources to be successful. With a list of events, Activities can plan and put on the events instead of spending energy deciding what events to host. The balance between the 2<sup>nd</sup> and 3<sup>rd</sup> concepts is about giving the subcommittee the authority it needs to carry out the task assigned to it while at the same time giving it enough direction to satisfy the groups. Several years ago the AASC groups decided what events they wanted and save for Unity Day, this is the list.

Secondly, the motion is intended to help AASC sustain services. Having two fundraisers per year is one of the recommendations of the 2011 ad-hoc budget subcommittee. This provision ensures that Area Activities is self sustaining (not a drag on our 7<sup>th</sup> Tradition) and may help subsidize other essential services – H&I, PI, or Storage, which do not lend themselves to fund raising.

It is intended that Activities Subcommittee play a support role in Learning Days. AASC or the other subcommittees should drive it and Activities support it.

This motion is not intended to stifle creativity. The activities committee is encouraged to put on other events or activities that it deems the AASC fellowship wants. However, it should inform the AASC of its plans ahead of time. This is consistent with principles of accountability and communication outlined in our Concepts.

disagreements and conflicts, “we can disagree without being disagreeable”. (Basic Text on Tradition 1).

What is the nature of our disagreement? On the one hand, the Convention Committee policy is that the Convention is an adult event. Consistent with that, children and non-addict spouses of addicts are charged the full \$40 each, which is the same registration fee as addicts. The fee serves as a “deterrent” from members bringing their chil-

dren. Notwithstanding, the committee has given Charlotte, the Convention Registration Chair, latitude to waive the fee for children and non-addicts (spouses).

On the other hand, some members wonder why this is necessarily an adult event. Why is a celebration of recovery not a family event? Also some of our members think that charging children and non-addicts violates the 7th Tradition.

We honor the Convention Committee. All of the sub-committees have and continue to work very hard. All members were part of the decision making process in open discussion at a regularly convened Committee meeting. And one could add most are parents. Part of this decision was based on precedent; non-addict spouses and children have been charged the registration fee during past conventions.

In light of the 9th Concept all of our committees should



actively seek out all available viewpoints". Here is an alternative:

The Convention Committee amends the registration guidelines as follows:

- The registration fee for children 14 and under will be waived, but they will be charged for the meals, and half price for the dance.
- Non-addict spouses and dependents above 14 will be charged a special \$10 registration fee, which would pay for coffee, tea, or snack provided gratis at the convention, and full price for other paid events.

Such a policy amendment would ensure that (i) parents with children are welcome and that (ii) we are self supporting through our own contributions. (iii) It might also help registration do its job.

When the fellowship has been assured that the Convention Committee has carefully considered all "viewpoints", then it is time to move into acceptance. Now that is Unity.


### Sisters In Solution Celebration
