ANCHORAGE AREA MEETING — DECEMBER, 2012

Anchorage Area Service Committee met in regular session on December 3.

The motion on whether or not to place the web servant as its own standing subcommittee or under Public information was voted on. A seven to five vote, with some abstaining, put the Web servant as its own standing subcommittee. There was some confusion surrounding the vote when a member asked for clarification concerning some verbiage in the original motion, and stated that his group would like to change their vote, with the new information given. The vote had already been taken at that point and the chair decided to allow the vote to stand. With minor grievance, Area service carried on in the usual manner and business was conducted swiftly. Debbie S. and Ashley A. were nominated for H & I chairperson. Look for qualification within. The Morning After Group made a motion that Area give the H & I committee \$220 for 20 new NA books to start there NA book drive.

It is H&I's assessment that there is a great need for NA literature on the shelves of treatment, halfway houses, and other recovery facilities, and a book drive is an excellent way of providing the needed literature. H&I is asking all members to donate used books or monies to their committee for this reason.

Also an 'in house' vote was taken at Area that posed the question, "Should we continue with the tradition and concept portion of the area service meeting, or discontinue it as it has cycled through all twelve at this point?" As a side note, the 12 traditions and 12 concepts informational presentation has been going on at Area for the last year. Each month two of our members present one tradition and once concept each to all present including GSRs, Area service officers, and others. Their presentation is supposed to be five minutes or less. Some members who participate in this presentation are happy with the knowledge they receive and get to present, while others have reasons for it not necessarily being a part of Area Service, but more a learning day's event

or non-business related. Others have personal reasons for making Area one hour, as there are families and such to be with. The vote was taken and was a tie with 6 yea's and 6 nays. The chair person, Sean C broke the tie with, "Who wants to do the first Tradition and first Concept next month?! (The Chair rarely votes, but does in the event of a tie.)

The clearance process works as follows: (i) fill out Anchorage Jail clearance application and give the application to the H&I Committee. (ii) H&I forwards the application to Anchorage Jail for Clearance. (iii) Anchorage Jail evaluates the clearance application — this can take 2 months. (iv) when you are approved, you meet with Anchorage Jail security for a badge and sign conditions, (v) carry message to incarcerated addicts.


Pokai Bay Meeting

Lou Ann and I recently went to the Thursday night meeting of NA in Pokai Bay Beach Park in Waianae, on the western side of Oahu. Actually the name of the meeting on the Hawaiian regional schedule is "Kaimi Na'auao" meeting, which from what I Googled means "Searching for Truth of" meeting of NA. However, we have always thought of it as the "the Thursday night Pokai Bay meeting of NA" or "This is my Cherry Home Group" meeting of NA because members frequently say that during introductions. But "searching for truth" is cool too.

The Pokai meeting is an outdoor meeting which meets from 8 pm to 9:30 pm and one hears the sound of surf in the background. Last month, there were 15 to 25 members gathered in a circle, some on blankets, some sitting on the ground, and some, like us, were in collapsible canvas chairs. The meeting had grown since we had been 3 years ago. That night there was rain, there were 4 of us, including Lou Ann and I, and the meeting was held under the eave of the bathroom facility. The meeting opened with

the Serenity Prayer and closed with the NA 3rd Step Prayer.

The night we were there, a woman with two years was the speaker. She was clean from Meth. She said a lot in the 30 minute share. What struck me was her saying, "I have my Auntie's and my Mother's respect". I was tuned in because that's cool to get the respect we crave. However, she turned it on its head by saying, "I respect my Mother for what she does for my family", and "I respect my Aunt, and my boss for what they do". It reminded me of the St Francis prayer, in the vein of "let me not seek to be understood, but to understand..." only about respect instead of understanding. Others shared after her.



Another thing, it was 65 degrees and there were a few folks shivering. Not me. Not a bit. If you are ever in Waianae of an evening, Pokai Bay has an NA meeting on Thursday and Friday nights.

My program, Your program, The Program

MY PROGRAM:

- ◆ Attend meetings regularly (daily for the most part)
- ◆ Work the steps with a sponsor or NA member on paper, learn to practice the principles of each step in daily life. Acceptance, trust, faith, etc.
- ◆ Reach out to the newcomer and make him or her feel as welcome as possible. Answer any questions they may have about Narcotics Anonymous and how it might benefit them to become a member and learn to live clean through the steps.
- ◆ Chair meetings, speak in meetings, listen when other people are speaking in meetings
- ◆ Do NA service work. If the meeting stacks chairs at the end, stack a few chairs. If the meeting asks for help cleaning up afterwards, be mindful and lend a hand from time to time, attend home group business meetings and participate at the group level, pay attention to what is happening at the Area Service level and vote when there are motions to be voted on. Participate with sub-committees. My method; take small bites. There will always be service work to do. Don't get overwhelmed and do too much at once. Make firm commitments to the service work I decide to participate in and in this way build integrity for myself and in others eyes.
- ◆ Sponsor other NA members. It's a privilege to be a sponsor. It can also be time consuming. It's ok to limit the amount of actual spesonees one might have. Every person that asks me to sponsor them deserve an equal amount of sponsor time and devotion. It's worth

the energy and time, to give back what was freely given to me.

- ◆ Tell the truth about what is going on in life, leaving nothing unsaid. Secrets still keep me sick, no matter how much time I have or how strong a program I think I'm working.
- ◆ Be nice to other members and strive to correct problems and disagreements quickly. One of the hardest parts of being an NA member is sticking around in the face of problems, broken friendship's and intimate relationships. My sponsor is quick to point out that the depth of my personal relationships with other members and other earthlings is what I'm willing to invest in them. I can't cry or whine for weeks and months on end without eventually owning my part and cleaning my side of the street. If, I want to recover that is. Hardship within the rooms of NA can kill addicts. Addicts who are unwilling to own their part and move into a spiritual place of grace and humility are in bad company, and heading towards relapse. If you can't help an addict, don't hurt an addict.
- ◆ Build on existing relationships
- ◆ Attend meetings for one purpose. Recovery from addiction
- ◆ Read NA literature, follow sponsor suggestions and suggestions spoken aloud in NA meetings.


