ANCHORAGE AREA MEETING— MARCH 4, 2013

Anchorage Area met in regular session March 4, 2013.

Treasurer, Josh, provided the 12 month report, which indicated that our net income/expenditures for the year is -\$58.63. That is a pretty balanced expenditure. The bank balance is \$3,628, which is \$2128 over the \$1500 prudent reserve.

Old Business from last month:

- The motion that Anchorage Area host the 2014 Regional Convention passed with strong support. This motion will now be introduced at Region to be sent back to the other Areas for a vote.
- The vote to approve the Regional budget passed with strong support. Our Regional Committee Member will now vote this with other Areas at the next Regional meeting. (The biggest variable at Region is if we have a quorum and/or if the Areas voted the business at their respective meetings.)
- The vote for Dennis A, nominated by Kenai Area, for Regional PI, passed with strong support. Our RCM will take this vote back to Region.
- The vote to waive the rule that Subcommittee Chair nominees have to be physically present so Debbie S could be nominated for H&I chair passed. It was not unanimous.

New Business

- **Groups brought nominations** for all positions except newsletter. H&I has three candidates. See Below.

- Clean and Serene brought a motion to **amend the Newsletter section of the Guidelines**. See page 2 for the full draft.
- 907 Recovery brought a motion to **add Web servant section to our Guidelines**.

Clean and Serene brought a motion to amend our Area Guidelines by adding the following to Section 10, part 5 “Newsletter”:

Newsletter Mission Statement

The Newsletter mission is to serve and unify our community by:

- i. Providing a means for members to share their recovery through the written word;
- ii. Supplying a venue for members to voice an opinion tempered by kindness and respect;
- iii. Communicating Area and Regional news so that our members and groups may be more informed;
- iv. Reporting about events and recognizing service contributions so that our members may better find fulfillment in service.

Newsletter Committee is mindful that a “a conscience

fed on ignorance is an ineffective conscience, incapable of providing reliable guidance” – Concept 8.

THE INTENT of this motion is to provide some guidance to newsletter committee about what types of material they might include in the newsletter.

Part ii incorporates Concept 9 – *All elements of our service structure have the responsibility to carefully consider all viewpoints in their decision-making processes.*

Part iii reflects Concept 8 -- *Our service structure depends on the integrity and effectiveness of our communication.*

Part iv, “recognizing service contributions” derives from NA World Services Mission Statement -- *Every member, inspired by the gift of recovery, experiences spiritual growth and fulfillment through service.*

“AASC Web servant Position


(a) **Description:** The Area Web servant position is a subcommittee of AASC, which reports to AASC. The subcommittee is responsible for updating the Anchorage Area portion of the Regional website and may include members, assistants, and technicians. The Area Web servant ensures that the most current information is available to members of Narcotics Anonymous and other interested persons. Although technical skills are necessary to update the website, the purpose of the Web servant is to ensure current information is updated for public access. Term limits do not apply to this position”

Circle of Sisters by Mandy

Over this St. Patrick's weekend, the annual Circle of Sisters celebrated their 16th year, in Tulsa, Oklahoma. Circle of Sisters is an all women's Narcotics Anonymous convention held in a different state every year. Women came from many areas of the world, from Canada to Bermuda to celebrate women in recovery. What an experience this was to be able go on mini vacation with some of my sisters in the program and my sponsor. The entire convention had many workshops and several speakers that touched on issues that as addicts, we go through in our recovery.



My highlight at the convention was a workshop called “We are never alone”. An addict named Faye from Texas spoke about the loneliness. She spoke about the feeling of being alone and the feeling of complete loneliness even when in a room full of people. This touched on my heart to the core. I grabbed a hold of every word she said like I did when I went to my very first meeting in Narcotics Anonymous. Sometimes it's not about picking up dope; often in my recovery it's about feelings, living life on life's terms and trusting my Higher Power to get me through the loneliness and surrendering my will. She read the solution out of the Basic Text, that to lose the feelings of loneliness is a continued conscious contact with a Higher Power.

Overall I had a beautiful time with my girls in recovery and was also able to hear a clear message of recovery. This is a worldwide fellowship and we're united with our addiction and our recovery.



NA in Abu Dhabi

Chris Yo recently visited family in the City of Abu Dhabi, which is located in the United Arab Emirates. Abu Dhabi faces the Persian

Gulf. Being removed from his recovery buds in Anchorage, Chris did what any reasonably well grounded addict might do — he called the local United Arab Emirate NA hotline and asked for the nearest meeting—he talked to a live addict. Chris could not find the meeting so after his third call, the NA hotline tender, roused another member to

pick Chris up and give him a ride. Chris said the meeting was in English with occasional Arabic. Chris found home away from home. Wow, what service: phone lines, give a ride, meeting. From Entitlement to Surrender

The Indians of old use to count coup, by how well they could steal from their enemies. And, I, being a Tlingit, stole just about everything I could get my hands on to help support my habit, from boosting to robbing banks and back to boosting. I believed society owed it to me for a crappy childhood and just being stuck on this planet.



I used drugs to run away, only I couldn't run away from myself for very long at a time. I've been to meetings, meetings, meetings and more meetings – AA, NA, CA, MA. I've been in five in-patient treatment centers, six out-patient treatments, and federal prison for a few years and now I'm sitting in a halfway house for the third winter in a row. Finally, I'm wore out. I give up! Drugs won; I'm not

willing to pay the price anymore. Now, what am I gonna do? I got nothing else to lose. I reached out for help and am now doing the unthinkable! I admit I am powerless. I know the unmanageability of my life. All the self searching and trusting the process, ask HP for help via the 12 Steps of Narcotics Anonymous. A loving member of NA brought me a How & Why book and a workbook. I got my hands on a Basic Text during an NA meeting brought in by H&I committee member (I promised to pay for it later). I just completed my 6th Step with my sponsor. We talk and laugh (can you dig it?) I laugh! For the first time, I'm going after this recovery thing to the best of my present ability. From self pity and fear to gratitude and trust.

The 907 Recovery Group of NA makes a motion to amend the guidelines to include a Webservant Subcommittee. (i) "Webservant" would be included in the list of standing subcommittees in Section IX, part 1 of the Area Guidelines. (ii) The Webservant position description, qualifications, and duties, as shown below, would be included as Article X, Section 6 in the Area Guidelines.

1. AASC Webservant Position

(a) Description: The Area Webservant position is a subcommittee of AASC, which reports to AASC. The subcommittee is responsible for updating the Anchorage Area portion of the Regional website and may include members, assistants, and technicians. The Area Webservant ensures that the most current information is available to members of Narcotics Anonymous and other interested persons. Although technical skills are necessary to update the website, the purpose of the Webservant is to ensure current information is updated for public access. Term limits do not apply to this position.

(b) Personal Qualifications:

- Two years or more of continuous abstinence from all drugs
- An understanding of or a commitment to learning and upholding the Twelve Traditions and Twelve Concepts of NA Service
- Willingness and ability to fulfill the responsibilities of the position
- Willing to become familiar with Public Relations Handbook chapter 10, "Internet Technology".
- Adopt an attitude to promote unity within AASC and throughout the service area.

(c) Technical Qualifications:

- Has internet access and email
- Ability to use a computer, Microsoft Office, Adobe Reader, and web designer tools
- Ability to use file transfer tools to upload files to the web server
- Convert documents to Adobe PDF's

(d) Responsibilities:

- Update the Anchorage Area portion of the Regional website, <http://www.akna.org/areas/anchorage>
- Communicate and coordinate with the Regional Webservant, Anchorage Area Service Committee, and other interested persons
- Provide a written monthly report to the Area Secretary. Regular attendance at Area meetings is required.
- Upload area service minutes, meeting schedules, newsletters, treasurer reports, and contact information
- Organize the webpage for area service minutes, meeting schedules, newsletters, treasurer reports, and contact information

(e) Legal:

- Anonymity – The Webservant is tasked with ensuring the anonymity of individuals is protected. Personal information is not posted without the prior knowledge and consent of members.
- Release of Information – When deemed appropriate by the Webservant, a Release of Information will be required prior to posting certain sensitive information.
- Copyright – The Webservant guards against copyright infringement of others' intellectual work. Additionally, the Webservant protects the copyright of the website.

INTENT: It is the intent of this motion to establish and describe a Webservant subcommittee within the Anchorage Area Service Committee Guidelines.

COST: There are no costs associated with passing or not this motion.
