Ad Hoc Committee Report

We have just finished going through the guild lines and had many discussions on the impact and meaning of each guild line. We want to remind the Area that guild line number four was approved by Area to add eligible voting before groups in the guild line and it hasn't been change yet on the GAHNA

website. As the Area changes the guild lines should also change to reflect the Area. In a sense the guild lines should be a living document. The Ad Hoc has came up with several proposals to change some of the guild lines and written the intent of each proposal. We leave it up to the groups to go through and see what proposals they want and which they don't. I hope that these proposals will encourage groups to read over and talk about the GAHNA guild lines as this committee has helped encourage our understanding and communication of traditions and Area itself. Thank you for letting us serve and for the opportunity.

Proposal #1

To remove "s" from "Areas" in guideline number 4 of the GHANA Guidelines.
Intent:

This has been said to be a grammatical error from a few members who were around when the guidelines were written. Also unchanged it would show that multiple Areas run under our guidelines when only one Area actually does.

Proposal #2

To insert "Eligible" before "voting members" in guidelines 6 and 7.

Intent:

This is to conform to a motion passed as of 8/13/2015 which changed guideline 4 from "groups" to "eligible voting groups".

Proposal #3

To replace "A Temporary Working Guide to our Service Structure (TWGSS)" in guideline 8 with "The Local Guide to Area Service".

Intent:

This is being done to update our Area from outdated sources and to follow with guideline 1.

Proposal #4

To remove "s" from "Subcommittee(s) Chairpersons" in guideline 8.

Intent:

This is another grammatical error that has been overlooked and might as well be changed as it has no effect on the guidelines either way.

Proposal #5

To remove "The Area Secretary will track terms of office; from election to the end of the service commitment." from guideline 8.

Intent

Since each office, excluding the RCM, only serves in one year increments and end at the same time each year, unless said offices become available via default or withdraw, there is no reason to keep track of terms of service.

Proposal #6

To add "as well as follow GHANA Guidelines" after "guidelines" in guideline 9. Intent:

Each Subcommittee is a part of GHANA and should conform to the rules at an Area level.

Proposal #7

To add ". Subcommittee Chairpersons" between "Vice-chair" and "must" in guideline 9.

Intent:

Before this change it implies that the Vice-chair be required to make a report to Area on all Subcommittees. Since each Subcommittee already provides a report there is no need for the Vice-chair to do so as well.

Proposal #8

To replace "cannot vote" with "are not eligible to vote" in guideline 12.

Intent:

This as well is to conform to the motion passed in 8/13/2015.

Proposal #9

To replace "placed onto the monthly agenda" with "submitted to the Chairperson within 14 days of the nomination, to be placed onto the following monthly agenda" in guideline 14.

Intent:

This gives a distinct deadline and party for the nominees to turn in their resumes since nominations do not come direct from the nominees.

Proposal #10

To rewrite guideline 16 to read "The area will send donations to Region (ARNA) quarterly."

Intent:

The previous guild line is confusing and since Area can donate to Region and then Region to World. Different years are more costly than the previous, like this year in which we have the blowout and convention to host. The Area is allowed to discuss financial matters and decide on how much to send to region since financial situations are in constant flux the amount sent to Region should be able

to vary as well. Proposal #11

To add "Treasury Chair" after "Literature Chair" in guideline 17.

Intent:

This is to add the Treasury Chairperson to the mailbox list as the bank uses the GHANA mailbox to send mail.

Proposal #12

To remove guideline 20 and guideline 21.

Intent:

These guild lines use very broad terms that are up to interpretation. Both also imply that without these guild lines GSR's can't make any decisions at area, which is not true. There is a lot of NA literature that talks about the responsibilities of a GSR such as The Local Guide to Area Service, IP The Group, GHANA GSR Packet, and much more. Removal of these guild lines would return the delegated responsibility back to the GSR's so that they fulfill their responsibilities to their groups and Area.

Note: If these guild lines are kept it would be helpful to define some of the terms such as, "housekeeping" and "expedited".
