Zonal forum discussion centered on the 3 zonal forums Canadian, Western States and Asia Pacific. Various aspects were discussed including maturity of forums and what Alaska Region could gain from being apart of that particular forum. It was decided the Asia Pacific forum and the Alaska Region do not have enough in common to consider joining. Cost of attendance at the Asia Pacific forums meeting would be prohibitive and there membership body needs more help than it can give. Canadian forum has some commonality including indigenous population, but they are Canadian and at this time do not include any other regions from outside of Canada. Western States are mature and could possibly help us in development. Cost to attend Western States meetings would be with in Alaska Region's means.

Motion Robert G. moved that Alaska Region join Western States Regional Forum. Christy W. seconded motion. Vote -4 yes, 0 no, 0 abstention. RCMs to take this motion back to their Area's for a vote before October 2009 Regional meeting.

New Business

2009 Unity Day discussion on what areas might need Regional support for the \$50 cost for a phone line. Anchorage, Golden Heart and Kenai are self-supporting and do not need help from Region. Juneau asked for the \$50 support.

Motion: Robert G. moved for \$50 Unity Day conference line support for Juneau Area. Christy W. 2nd. Vote – 4 yes, 0 no and 0 abstention. Motion passed. Charlotte will send \$ to Robert G.
