ARD report July 17, 2010 Howdy Family,

I submitted my expense report with receipts on May 16th for the WSC I attended on your behalf. I exceeded my budget of \$1,950 by \$88.71, which I have been reimbursed. I did reduce my per diem from the WSC rate from \$55 to \$42 to minimize costs (a savings of \$117). My written report is posted on our website. I did make a list of acronyms and their definitions used on the first page of my seven-page report. My goal was to prepare an outline of what I participated in, and an

overview of the topics covered in a chronological order. If anyone has feedback on how the report would work better for them please let me know.
