Assembly Ad-Hoc Committee - Doug P.

Hello Areas and Groups,

Alaska Region formed an ad hoc committee to plan a Group Service Representative (GSR) Assembly this Spring. We are tasked with reporting to the region about these plans at the January meeting. In order to help the Regional Committee act in January, we are distributing information regarding the Assembly in time for the Area meetings in December. This in turn would prepare our Areas to vote at the regular Regional meeting in January.

Purpose:

The purpose of the GSR Assembly is to develop or define the role and direction of the Alaska Regional Service Committee (ARSC) within the Alaskan NA fellowship. To this end, we seek to draft an ARSC *Vision Statement*.

Also, we seek to promote unity by providing a communication platform for our groups. This is consistent with, even driven by; the concept that *the final responsibility and authority for (our) NA services rests with the (Alaskan) NA Groups.* Moreover, we want to find how we may better serve our constituent Areas and groups. Since the final responsibility of ARSC rests with the groups, it is natural that we seek direction from the groups.

Finally we seek to raise understanding of Regional issues so that the full fellowship may help resolve our challenges. These challenges include communication, fellowship development, finance and budgeting, and remote area outreach services.

Draft Assembly Agenda:

The following items constitute the draft Assembly agenda.

- Vision Statement Development -- This is a workshop to draft a vision statement. The Vision Statement would guide the ARSC: the ARSC would do what is in the Vision Statement and not do what is not in it.
- Regional Finances and Budget This is an informational workshop regarding
 (i) ARSC budgets and expenditures over the last few years and (ii) the ARSC
 budget that will be in draft next spring.
- Narcotics Anonymous World Services (NAWS) what is it? This is a workshop on the basic structure of our NAWS from the NAWS Convention, the Conference, and Board to the Western States Zonal Forum. It would also include a brief update of any ongoing projects NAWS is doing.
- ARSC What does it do? From translation to website, you might be surprised at
 what our Region does. This section will include a time to gather feedback, "What
 do the GSRs want to see of ARSC."
- Rural Outreach -- How can we carry the message to our non-road system rural communities?
- Alaska Region on-line meeting.

Assembly Details

- April 9, a Saturday, has been set as the date for the Assembly. It will run from 10 am to 4:30 pm. The daytime Assembly will be combined with an evening entertainment event.
- The Assembly will be held in Anchorage, preliminarily at St. Patrick's (we do not have it booked yet).
- ARSC would fund the Assembly, while the entertainment event will be hosted by the Kenai Convention committee. (It will be a convention entertainment event held in Anchorage.)
- The Assembly planning committee will work to identify members of the Anchorage fellowship that can host GSRs and Alternate GSRs (or others coming from out of town to the Assembly) to keep costs as low as possible for our traveling fellowship.
- Committee Members are Doug P, Howie W, Terrie H, Allen M, Tammy M, and Robert G. Anne H and Kathy W have also shown interest in participating.

There are a couple of action items. The Regional committee made a decision to *plan* the Assembly, but no decision was made to actually hold the Assembly. It would be helpful if the Areas were prepared to vote on the following at the regular Regional meeting in January.
