NEW BUSINESS

Report of 2008 Convention: The group went over the brief synopsis of the 2008 convention held in our area. We went over location, expenses, and profits that were derived from the minutes.

Service Positions: We discussed clean time requirements as stated in the NA Convention Guidelines and when we should nominate members for any service positions for our upcoming committees. The 2008 convention did not have an "Arts & Graphics" subcommittee. The group decided to wait until after this year's convention to make any of those decisions. The group decided to appoint Malia Acting Secretary until that time.

Speaker Meetings & Workshops: We discussed whether we should have workshops at the convention. 2008 convention did not have workshops but other conventions not hosted by the Golden Heart Area have. The 2008 convention had 4 speaker meetings: Friday night, Saturday morning and night, and Sunday morning.

Finance: The group discussed the financial concerns for putting on this event and were told that there would hopefully be seed money provided by Region and the amount would be dependent on the success of this year's convention. We also discussed the benefits of fundraising over the year that would directly benefit the upcoming convention, and that we will need to promote convention awareness.

Theme & Logo: The first issue that we should address is the Theme for our convention. We will take this information back to groups and ask for theme ideas. This is separate of Logo design, and we must find a Recovery based theme, possibly driven from NA Literature. This Theme "Contest" shall precede any logo contest.

Location: The location for our 2013 Convention shall be decided based on which venue will provide us with the accommodations we need at the best price, to include, conference/banquet room(s), hotel rooms, and food. The 2008 hotel used was the Alpine lodge and we have the paperwork from 2008. Our team will write list of needs and get bids from various locations in town to include the Alpine Lodge, Pike's, Chena Hot Springs, Westmark, Wedgewood, Princess, and the Marriot Springfield Suites.
